PRINCIPLES



CONTRACT UPDATE

Congratulations on the ratification of our new contract. The contract was ratified with a vote of 98.3%. A few highlights are the 8% raise, Legal Services Plan and improved working and professional development gains. We are hopeful that the City Council can vote on our agreement before they recess on July 15, 2019. We currently are awaiting one final signature before the contract can be presented. CSO will keep you updated on the approval process, but believe we will not receive our retroactive pay until September 2019 or later.
